<p><b>Removal goods</b></p>	<p>SLOVENIAN citizens:</p> <ul style="list-style-type: none"> <li>▪ Passport (original or verified copy).</li> <li>▪ Inventory.</li> <li>▪ Shipper's Slovenian Tax number.</li> <li>▪ Registration of residence in Slovenia.</li> <li>▪ A Statement issued by Slovenian Consulate, confirming that the shipper has lived outside EU more than 12 months. It must state dates of employment and termination.</li> <li>▪ In case Slovenian Consulate is not available such Statement is accepted if issued by shipper's Employer abroad</li> <li>▪ A letter signed by the shipper that he will live in Slovenia, all the goods are in his possession and used more than six months and that he did not import other households or personal effects in last 12 months.</li> </ul> <p>EU citizens:</p> <ul style="list-style-type: none"> <li>▪ Passport.</li> <li>▪ Inventory.</li> <li>▪ Registration of residence in Slovenia.</li> <li>▪ A Statement issued by shipper's Employer abroad confirming that the shipper has lived outside EU more than 12 months. It must state dates of employment and termination.</li> <li>▪ A letter signed by the shipper that he will live in Slovenia, all the goods are in his possession and used more than six months</li> </ul>	<ul style="list-style-type: none"> <li>▪ Tax-free import is only possible within 12 months after arriving / returning to Slovenia (EU).</li> <li>▪ All the goods intended for import must be declared to customs upon first import customs clearance.</li> <li>▪ Goods must not be sold, hired, lent or otherwise disposed within 12 months after importation.</li> </ul>	<ul style="list-style-type: none"> <li>▪ In case the letter from a third party confirming that shipper has lived outside EU is not available, other documents not specified but clearly proving living outside EU are acceptable.</li> <li>▪ Sometimes Customs may require also other documents like rental contract, copy of employment contract and others.</li> <li>▪ If shipper cannot present complete import documents contact your FIDI agent (for possibilities to release the goods from Customs).</li> </ul>

	<p>and that he did not import other households or personal effects in last 12 months.</p> <p>NON-EU citizens:</p> <ul style="list-style-type: none"> <li>▪ Passport.</li> <li>▪ Inventory.</li> <li>▪ Statement from Slovenian employer confirming that the shipper will be employed with them.</li> <li>▪ Registration of residence in Slovenia.</li> <li>▪ A letter signed by the shipper that he will live in Slovenia, all the goods are in his possession and used more than six months and that he did not import other households or personal effects in the last 12 months.</li> </ul> <p>STUDENTS:</p> <ul style="list-style-type: none"> <li>▪ Letter from University confirming student's status.</li> </ul>		
<b>Diplomatic Moves</b>	<ul style="list-style-type: none"> <li>▪ Inventory.</li> <li>▪ Diplomatic ID.</li> <li>▪ Duty and Tax Exemption Certificate issued by Slovenian Ministry of Finance.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Import of alcohol and tobacco products is allowed for diplomats but limited to three months (quarterly) quota agreed by Slovenian Ministry of Foreign Affairs and the respective Embassy.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Copy of Passport is acceptable in case Diplomatic ID is not yet available</li> </ul>
<b>Cars, motorcycles, scooters, mopeds, boats</b>	<ul style="list-style-type: none"> <li>▪ Same documents as for import of households plus: <ul style="list-style-type: none"> <li>▪ Purchase invoice.</li> <li>▪ Car's documents from country of purchase or export.</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ Tax on Motor Vehicles (DMV) is applicable. Varies from 0.5 – 41% (cars), 1,5-10% (motorcycles) of Eurotax value depending on type of fuel, engine power, and CO2 emissions. DMV is partly refundable upon export.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Clearance is separate from removal goods.</li> <li>▪ After clearance, technical examination is required to obtain Certificate of Homologation (Potrdilo o skladnosti).</li> </ul>

<b>Unaccompanied air baggage</b>	<ul style="list-style-type: none"> <li>▪ Passport copy.</li> <li>▪ Inventory with value.</li> </ul>		<ul style="list-style-type: none"> <li>▪ Only for shipments arriving by air (NOT road) containing mostly clothes and small amounts of other items for personal use.</li> </ul>
<b>Wedding Trousseaux</b>	<ul style="list-style-type: none"> <li>▪ Passport.</li> <li>▪ Inventory.</li> <li>▪ Certificate of marriage.</li> <li>▪ Registration of residence in Slovenia.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Alcohol, tobacco, foodstuff cannot be imported as part of households.</li> </ul>	
<b>Inheritance</b>	<ul style="list-style-type: none"> <li>▪ Death Certificate.</li> <li>▪ Copy of the will or Statement from the Court.</li> <li>▪ Beneficiary's ID and tax number.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Alcohol, tobacco, foodstuff cannot be imported as part of households.</li> </ul>	
<b>Pets</b>	<ul style="list-style-type: none"> <li>▪ International Health Certificate.</li> <li>▪ Microchip (or tattoo).</li> <li>▪ Vaccination Certificate.</li> </ul>		<ul style="list-style-type: none"> <li>▪ Import documentation depends on kind of animal.</li> </ul>
<b>Antiques, artworks</b>	<ul style="list-style-type: none"> <li>▪ Import (or export) permit issued by Cultural Ministry.</li> </ul>		
<b>New items</b>	<ul style="list-style-type: none"> <li>▪ Purchase invoice.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Subject to customs duty and VAT. Current VAT is 22%.</li> </ul>	
<b>Alcohol, tobacco, foodstuff</b>	<ul style="list-style-type: none"> <li>▪ List of beverages with description.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty and tax are applicable for import of alcoholic beverages and tobacco.</li> <li>▪ Small amounts of foodstuffs can be imported as part of removal goods.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Alcohol and tobacco cannot be imported as part of removal goods.</li> <li>▪ Small amounts of foodstuff for personal use can be imported as part of removal goods.</li> </ul>
<b>Arms and ammunition</b>	<ul style="list-style-type: none"> <li>▪ Import permit is necessary.</li> <li>▪ Gun and hunting licence.</li> </ul>		<ul style="list-style-type: none"> <li>▪ Must be declared separately, special inspection is required.</li> </ul>
<b>Drugs</b>		<ul style="list-style-type: none"> <li>▪ Import prohibited.</li> </ul>

Solid wood packing material		<ul style="list-style-type: none"> <li>▪ According to EU regulations all imported solid wood packaging must carry the ISPM15 mark indicating that all the timber has received appropriate treatment.</li> </ul>
